PRIVACY POLICY

PatetLex developed *Vitalitas* as a Free app, hosted on the Microsoft Software Store. This SERVICE is provided by PatetLex at no base cost to the user and is intended to be used freely. Priced packages can be subscribed to and synced on online servers. This document intends to clarify the disclosure, use, and location of Personal Information inputted into *Vitalitas*. Standardly, PatetLex will not use or disclose any information except as presented in the document.

All information inputted into the *Vitalitas* app is stored on a secure online database.
